# (3) OBJECTIVE

Powering Healthcare's main objective is to support the growing number of governments and development partners seeking to electrify healthcare facilities by:

- · generating better sector intelligence;
- driving the uptake of data, technology and financial innovation:
- amplifying global advocacy efforts to raise ambition and strengthen cooperation and knowledge exchange among health and energy actors.

# SCOPE

Currently, thousands of health facilities lack reliable power and long-term, sustainable energy solutions to enable the delivery of quality health services to millions of people.

The Powering Healthcare programme's activities focus on fostering innovations and new technologies, generating data and providing thought leadership and coordination for the global health facility electrification sector.

### **EXPECTED OUTCOMES**

- More innovative approaches followed in designing health facility electrification programmes, in terms of technologies, delivery models and financing.
- Stronger commitments and policies from governments and their development partners to address health facility electrification
- Increased investment in health facility electrification
- Improved policy environments and market conditions

# **\** APPROACH & PRODUCTS

Timeline: September 2022 - December 2026

#### STATE OF THE MARKET REPORT

The State of the Market Report will provide stakeholders with the most up to date information about the scope, scale, and location of health facility electrification projects around the world. An assessment that provides an overview of the current and projected market for health facility electrification, with insights into trends and experiences gained from the market's development to-date.

#### **INNOVATION FUND**

An innovation fund will be set up to accelerate the sector by providing small grants for innovative and potentially catalytic interventions.

#### CAPITAL LANDSCAPE STUDY

A detailed analysis of the capital flows, sources, constraints and opportunities for financing the electrification of healthcare facilities will provide the healthcare electrification sector with better insights on funding gaps.

#### **DE-RISKING INSTRUMENT**

A de-risking instrument will mitigate risks associated with energy-as-a-service models, with the aim of increasing investor confidence in the electrification of healthcare facilities.

#### **GLOBAL COORDINATION & LEADERSHIP**

The Energy Compact for Health Facility Electrification, supported by more than 20 organisations, provides a sectoral target for health facility electrification and is a strong mechanism to raise ambition and drive new commitments. With TEA's support, SEforALL wants to further raise ambition and set additional intermediate targets that aim to close the energy access gap in the health sector fully by 2030.
